In consideration of my engagement as a model, and for other good and valuable consideration herein acknowledged as received, I hereby grant the following rights and permissions to Jason Duchow Photography, their legal representatives, and assigns, those for whom Photographer is acting, and those acting with their authority and permission. They have the irrevocable, perpetual and unrestricted right and permission to take, use, re-use, publish, and republish photographic portraits, pictures and/or video of me or in which I may be included, in whole or in part, or composite or distorted in character or form, without restriction as to changes or alterations, in conjunction with my own or a fictitious name, or reproductions thereof in color or otherwise, made through any medium at his/her studios or elsewhere, and in any and all media now or hereafter known, specifically including but not limited to print media and distribution over the Internet for illustration, promotion, art, editorial, advertising, trade, or any other purpose whatsoever. I specifically consent to the digital compositing or distortion of the portraits or pictures, including without restriction any changes or alterations as to color, size, shape, perspective, context, foreground or background. I also consent to the use of any published matter in conjunction with such photographs. I hereby waive any right that I may have to inspect or approve the finished product or products and the advertising copy or other matter that may be used in connection with them or the use to which they may be applied. I understand that the images of me may be used in Department/merchandise/electronics stores. I nevertheless consent to this use. Complete creative control is left to Jason Duchow Photography. I hereby release, discharge, and agree to hold harmless Jason Duchow Photography, his/her heirs, legal representatives, and assigns, and all persons acting under his/her permission or authority or those for whom he/she is acting, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of such photographs or in any subsequent processing of them, as well as any publication of them, including without limitation any claims for libel or violation of any right of publicity or privacy. Payments for the photo session will not be refunded or transferred for any reason. I hereby warrant that I am of full age and have the right to contract in my own name. I have read the above authorization, release, and agreement, prior to its execution, and I am fully familiar with the contents of this document. This document shall be binding upon me and my heirs, legal representatives, and assigns. RAW/unedited digital images will not be given out, under any circumstance. All photos will be used/shared in a tasteful and respectful manner. By signing this form, the guardian/client agree they understand the photographer is limited by the willingness of the athlete to participate in the photo session. It is the responsibility of the guardians and or athlete to ensure the client participates in all allotted poses. Up to 3 individual photos of each athlete can be taken, buddy shots count as an individual pose for each athlete in the buddy shot. Refunds will not be given if the client fails to participate in all poses. Final Images will be delivered via an Online digital gallery and include a print release. All photos are to be taken on the scheduled day, there are no retake days included. High resolution files are included and will be available to download. No prints are included.
